TERMS AND CONDITIONS

- 1. Finalists must be aged 18 years or over on the day of the races
- 2. Proof of age must be presented at the time of registration if requested
- 3. Finalists must not receive any form of compensation from a third party for entering Newcastle Racecourse Fashions on the Field competition.
- 4. Finalists and their outfits are not permitted to promote commercially a brand, designer or store
- 5. Finalists must not be dressed or styled by a designer or milliner
- 6. Finalists may not enter the competition on behalf of a third party
- 7.All prizes awarded to the winner must remain the property of the winner and are not transferrable, exchangeable or redeemable for cash
- 8. All prizes must be taken as specified
- 9. The Promoter is the Newcastle Jockey Club (Newcastle Racecourse)
- 10. The Promoter will select the judging panel. Finalists will be selected by the judges on the day and the judges' decision is final

COMPETITION CRITERIA

All finalists will be chosen based on the following criteria set out below. They acknowledge that they understand and agree to abide by the criteria in order to enter Newcastle Racecourse Fashions on the Field Competition:

- 1. All genders are eligible to enter Newcastle Racecourse Fashions on the Field Competition.
- 2. Ladies must be wearing a hat or head piece to be eligible for entry in the Newcastle Racecourse Fashions on the Field Competition. Hats or head pieces must be appropriate for the Spring Racing Carnival season.
- 3. Accessories are suggested to be matching or complimentary.
- 4. Entrants must reflect an appropriate, personal race wear style and it is favourable, however, not compulsory, to show an interpretation of the season's fashion directions.
- 5. Outfits must be appropriate for the occasion and season.
- 6. Gentlemen must wear a full suit and tie.
